



## Rating Action: Moody's upgrades to Aa1 Harpswell, ME's issuer rating and GOLT rating

New York, December 19, 2022 -- Moody's Investors Service has upgraded to Aa1 from Aa2 the Town of Harpswell, ME's issuer rating and General Obligation Limited Tax (GOLT) rating. The issuer rating reflects the town's ability to repay debt and debt-like obligations without consideration of any pledge, security or structural features. This action concludes a review that was initiated on November 3, 2022 in conjunction with the release of the US Cities and Counties Methodology. The town has \$4.3 million in long-term debt outstanding. The ratings under review outlook has been removed.

### RATINGS RATIONALE

The Aa1 issuer rating reflects a healthy economic base near the Portland MSA with a substantial portion of second homes in the area driving very significant full value per capita. However, the area maintains a very high median age at 61 years. The town's financial operations are strong and have remained stable for the last five years driven by conservative budgeting practices. Once the fiscal 2022 audit is reported, management expects additional improvements to fund balance. Through 2022, revenues and expenses are coming in line with the original budget. The town's long term liabilities are low, owing to the town's small pension and OPEB burdens. The town's debt burden is expected to remain manageable given a lack of significant issuance plans and management's preference to fund capital projects with reserves.

The Aa1 rating on the town's GOLT bonds is at the same level as the issuer rating because the town has pledged its faith, credit and taxing authority for repayment of the bonds.

### RATINGS OUTLOOK

Moody's does not usually assign outlooks to local government credits with this amount of debt outstanding.

- Material improvement in economic metrics
- Reduction in long-term liabilities

### FACTORS THAT COULD LEAD TO A DOWNGRADE OF THE RATINGS

- Decline in available reserves

### LEGAL SECURITY

The bonds are backed by the town's general obligation limited tax pledge, as the debt is subject to the state's property tax limitation known as LD-1.

## PROFILE

Harpswell is located on the coast of Maine, in the northeastern section of Cumberland County (Aa2) approximately 40 miles by road from Portland, ME (Aa1 stable). The town is a rural community with over 200 miles of coastline and an estimated year-round population of 5,031 that doubles during the summer months.
